- 2. Tenderers/bidders are requested to visit the website <u>https://eprocure.gov.in</u> regularly. Any changes/modifications in tender enquiry will be intimated by corrigendum through this website only.
- 3. In case, any holiday is declared by the Government on the day of opening, the tenders will be opened on the next working day at the same time. The Director, ICAR-NIHSAD reserves the right to accept or reject any or all the tenders.
- 4. The interested Firms are required to deposit (in original) the Tender cost (in shape of DD Only and an Earnest Money Deposit (EMD) of the amount mentioned against item in the form of Account Payee Demand Draft/FDR/TDR/Banker's Cheque/Bank Guarantee from any of the Commercial Banks in favour of <u>ICAR Unit, NIHSAD, Bhopal</u> payable at Bhopal may be addressed to Director, ICAR-NIHSAD, Bhopal 462022. The EMD can also be deposited online in an acceptable form on or before bid opening date and time as mentioned in the Critical Date Sheet. In case of depositing the EMD through online mode, proof of EMD (UTR No or any other) must be submitted alongwith tender. No quotation shall be considered without the earnest money deposit. Terms & Conditions

- 1. The tenderer shall quote rates, which will include the delivery & other incidental charges. Taxes etc. should be indicated separately.
- 2. The rates should be quoted as per the BOQ uploaded on the CPP Portal (reference may be obtained from Annexure III). Taxes, if any, should be indicated separately. It must be noted that the contract shall be awarded to the firm which fulfills all the required terms and conditions and remains L-1 for any particular items.
- 3. The firm must also possess valid PAN No., GST No. registration number and a copy of the same must also be enclosed with the tender documents.
- 4. The equipment quoted should be of latest technology. The spare parts of the equipment quoted should be available for next 10 years.
- 5. Modification in the tender documents after the closing date is not permissible.
- 6. The successful firm shall have to supply the Scientific Equipment within 30 days from the date of confirmed supply order and if the materials are not supplied in time then EMD shall be forfeited. The autoclave should be fitted with Non return valve, moisture trap, dial thermometer and pressure gauge or compound gauge.

General terms conditions:-

- 1. All the materials and fittings of the autoclave should meet the BIS standards (ISI Mark: IS 3829 I).
- 2. Chamber and steam jacket should be made up of Heavy gauge S.S. sheet with leak proof argon-arc welding.
- 3. The autoclave should be hydraulically tested to withstand 2.5 times the working pressure.
- 4. It is required to be mounted on tabular steel frame with ground leveling screwed flanges.
- 5. The outer jacket should be insulated with with asbestos sheet or glass wool or any other appropriate insulation to minimize the heat losses due to radiation

and should be covered by polished stainless steel sheet.

- 6. Sterilizer should have hinged self-locking single piece thick S.S. plate door that remains locked when under pressure with a self-locking device which automatically disengages the thread mechanism when the sterilizer is under pressure to preclude any eventually of accident.
- 7. The other chamber should have a spring loaded safety valve and a dead weight release valve to release the steam in case the pressure exceeds the safety limit.
- 8. Essential accessories: Hydraulic Trolley (Stainless steel) for loading the material in the horizontal autoclave.

PART B

ICAR-NIHSAD has a BSL-3 laboratory and the horizontal autoclave has to be installed inside the bio-containment laboratory. Installation of the Autoclave has to be carried out by the firm at the designated location which has a direct steam supply from the central boiler system.

- 9. The location where the autoclave is required to be fitted already contains piped steam supply. The steam will be made available at 2 to 3 kg/cm², from its source. The autoclave is required to be fitted to the existing steam source and all the costs for the fitting, installation, testing and commissioning should be quoted alongwith the offer. Any change of steam pressure, if required, will be in vendor's scope. Partial replacement of steam supply (if required) may also be considered in the offer.
- 10. In order to ensure the feasibility of successful procurement, installation and commissioning of the autoclave, the vendors may visit the location of the autoclave and inspect the existing facility prior to quoting the tenders to ascertain the requirements for successful fitting, installation, testing and commissioning of the autoclave.
- 11. No change in the offer for the installation and commissioning of the autoclave will be permitted once the offer is received by the institute.
- 12. The vendors must visit the laboratory facility during the designated office hours prior to the pre-bid date or within 15 days after the uploading of the tender on the website.
- 13. Comprehensive on-site warranty for Two Years.
- 14. The firms may also quote the maintenance cost (AMC) to be offered after the expiry of the onsite warranty of Two years. The quoting of the AMC should take into account the projected increase in relevant cost. The firm if offered the AMC, will have to abide by the rate of AMC quoted in this offer.
