Terms and conditions

- 1. Service Tax as applicable as per prevailing rates will be charged extra (current service tax @15% including 0.5% Swatch Bharat cess & 0.5% krishi kalyan cess)
- 2. Appropriate sample for each testing in good condition is to be supplied (in cold chain wherever required) at NIHSAD during working hours.
- 3. The samples must be accompanied by a covering letter, giving details of samples, diseases to be tested, correspondence Address, phone, fax and email. The perishable materials must be sent by special messenger maintaining the cold chain.
- 4. The sample testing will be done only on advance receipt of full payment, including service tax by demand draft in favour of "ICAR Unit, NIHSAD, BHOPAL" payable at Bhopal.
- 5. Prior Information should be communicated before importing the live animals.
- 6. The results will be communicated only after 7-10 days, after the receipt of samples.
- 7. The results for virus isolation and VNT will be communicated after 2 weeks only.
