2. Technical Eligibility Criteria:-

- (i) Experience of similar work such as Refilling, HPT, AMC of Fire Extinguishers and/or Fire Hydrant System for at least 3 works in last 4 years in Govt/PSU/Autonomous bodies/Local Govt./Reputed Process Industries. (All relevant documents to be enclosed). Scanned copy of the same may be furnished.
- (ii) The average Annual turnover during the last 3 years as on 31/03/2022 should beRs 5 lakh. Scanned copy of proof may be furnished.
- (iii) The owner or the employee of the firm should have Degree/Diploma/Certificate course (6 months & above) in Fire Safety from the government recognized institute and the certificates of proof shall be submitted along with bid. Scanned copy of the same may be furnished.
- (iv) The firm should have local office at Bhopal with technical staff qualified in Fire safety, proof for the same may be enclosed. Scanned copy of proof may be furnished.

4. Other Termsand Conditions:-

- 1. The awardee firm will be bound to furnish the break-up of quoted cost of each item (Fire Extinguishers, Fire Hydrant System) as mentioned in annexure I before award of AMC.
- 2. For CO_2 type extinguishers, purity of CO_2 gas should be 99% & above. The CO_2 puritycertificate must be submitted alongwith refilling otherwise Payment for refilling will not be released.
- 3. For DCP type extinguishers, MAP 90 grade shall be used. The certificates of batch testof DCP powder& MAP 90 from OEM must be submitted alongwith refilling otherwise Payment for refilling will not be released.
- 4. Hydraulic Pressure Testing (HPT) of the CO_2 type fire extinguishers must be carried out in PESO approved facility and Test Certificate issued by the Testing facility shall be submitted while claiming charges for HPT. Failing to provide valid HPT certificate, the charges for HPT will not be entertained.
- 5. For HPT & refilling the firm will be allowed to take 50% of the total No. of cylinders to be serviced at a time.
- 6. Only those bidders who qualify in the technical bid will be considered for opening and evaluation of financial bid
- 7. The firm may submit the EMD worth Rs. 5000/- (in shape of DD/FDR in favour of ICAR-Unit, NIHSAD, Bhopal)alongwith offer. The same may be submitted physically at Institute before opening of technical bids. The MSME/NSIC/Startup Firms are exempted for submission of EMD. Hence, firm may submit the EMD or its exemption, if any.
- 8. Firm has to deposit 3% of the total value as security money in shape of DD/FDR in favor of ICAR Unit, NIHSAD, Bhopal in physical form before undertaking the AMC/Job and furnishing of agreement on non-judicial stamp paper worth Rs.500/-
- 9. Spares for fire hydrant systems like gasket, oil, grease, gland packing, polish paper, cotton cloth, nut bolts washers, bearings, bushes, electrical items like MCB, motor starter, cables, relays fuses, bearing (only SKF), pump seal, glands, tools and tackles etc. required for maintenance, manpower etc. will be in bidder scope.
- 10. All repairing work including repairing of fire pump with motors, rewinding of motors, welding of MS pipe, replacement of electrical cables, relays, fuses, valves etc. required to maintain the fire hydrant systems in working condition will be in bidder scope.
- 11. The contractor shall not sublet the AMC services to any other agency.

- 12. In case of emergency, the firm shall give full support including personnel with degree/diploma/certificate course (6 months & above) in Fire Safetyfor mitigation of fire accident at no extra payment.
- 13. In case of tie in rates lowest quoted, the firm who have more experience will be considered for AOC.
- 14. Rates are to be quoted on FOR basis.
- 15. GST, if any are to be shown separatelyFirm may submit their PANTIN/GST number with a copy of proof thereofalongwith quotation/offer.
- 16. No advance payment. However, billing payment will be on quarterly basis after completion of period & due verification by the I/C Fire Section.
- 17. Repairing work will be carried out in place where machines are located.
- 18. Replaced parts should be of reputed make and old/worn out parts have to be returned to Store Section, NIHSAD as and when replaced with new parts.
- 19. Bidder may inspect the fire extinguishers, hydrant systemsbefore submitting their offers.
- 20. Any complaint lodged shall be attended on the same day and in any case within 24 hours.
- 21. Validity Offer 120 days.
- 22. If service/maintenance work is found unsatisfactory during AMC period thenAMC/Agreement may be terminated by giving 15 days prior notice to the vendor/contractor and firm will also be fined for Rs 10% of the total amount.
- 23. Transportation shall be in scope of bidder.
