1. Interested Candidates should submit Bio Data/application on the date of Walk-in-Interview as indicated against each project/scheme along with original certificates for verification and one set of self attested copies of all certificates of educational

- qualifications, mark sheets, provisional/original degree certificate and experience certificate etc. and a recent passport size photograph.
- 2. All eligible candidates are advised to be present at least 30 minutes before scheduled time on the date of interview for completing necessary formalities. No entry/registration after 10:00 A.M as per schedule of Walk-in-interview. Canvassing in any form will disqualify the candidates. The candidate (s) interested to attend the Walk-in-Interview must bring their original documents and typed application in prescribed format as per application details along with self-attested copies of his/her qualification, experience etc.
- 3. The engagement of Young Professional(s) will be on purely temporary basis and the selected candidates shall not have any right to claim for regular appointment under ICAR-NIHSAD, Bhopal (M.P). Initial engagement of ICAR Young Professional-I shall be for one year which is extendable for two more years (one year at a time) or termination of the projects or program whichever is earlier subject to requirement of the Institute and satisfactory performance of the candidate following evaluation. The ICAR-NIHSAD, Bhopal will hold no responsibility for payment of salary/regular appointment etc. after expiry/termination of the Scheme/Project.
- 4. Original Degree/Provisional Degree certificates, mark sheets and experience certificate (if any) will have to be produced at the time of interview. Those who do not posses Original Degree/ PDC certificate or having only xerox copies of the same at the time of interview will not be allowed to attend the Walk-in-Interview.
- 5. The general and other terms & conditions of the ICAR guidelines for hiring of technical manpower (Young Professional-I) on short term basis (O.M. F. No. Agri.Edn.I-06/2020 dated 04/12/2020) shall be applicable.
- 6. The candidates are requested to produce original caste/community certificate issued by the competent authority (a state/central government body, as applicable) at the time of interview.
- 7. No TA/DA will be paid to any candidate for attending the interview.
- 8. The decision of the Director, ICAR-NIHSAD will be final and binding in all respects in selection.
- 9. Only those who are interested to serve at least for a period of one year may attend the interview.
- 10. Candidates under employment shall submit NOC from the employer during interview.
- 11. All the candidates appearing Walk-in-Interview shall be screened and shortlisted before the interview and written test may also be conducted before the interview.
