Online Tender are hereby invited on behalf of the Director, ICAR-NIHSAD, Bhopal for PROVIDING AMC SERVICES FOR OPERATION & MAINTENANCE OF PLC AND STEAM BASED LIQUID WASTE STERILIZATION PLANT & ASSOCIATED ACCESSORIES OF BIO-CONTAINMENT FACILITY AT ICAR-NIHSAD, BHOPAL FOR A PERIOD OF ONE YEAR AND EXTENDABLE BY ONE MORE YEAR SUBJECT TO SATISFACTORY PERFORMANCE OF THE VENDOR AND MUTUAL AGREEMENT.

1. The terms and conditions of the contract are those contained in the general conditions of contract applicable to the contracts placed by the ICAR-NIHSAD as detailed in the tender forms and its schedules. Please submit your rates in the financial bid (BOQ) if you are in a position to furnish the requisite services in accordance with the requirements stated in the attached schedules.
2. Earnest money of Rs. 50,000/- must be deposited in the form of demand draft/FDR to ICAR Unit, NIHSAD, Bhopal **with the Director, ICAR-NIHSAD, Bhopal on or before the last date/time of submission mentioned in the tender schedule at page number 1.** The particulars of the earnest money deposited must also be mentioned in the technical bid (online) and scanned copy of EMD shall be uploaded. Conditional bids shall not be considered. No overwriting or cutting is permitted in the tender documents. Such bids will be outrightly rejected.
3. The tenderer is being permitted to give tenders in consideration of the stipulations on his part that after submitting his tenders, he will not resale from his offer or modify the terms and conditions thereof. If the tenderer fails to observe and comply with the foregoing stipulations, the aforesaid amount of EMD will be forfeited by the NIHSAD. In the event of the offer made by the tenderer not being accepted, the amount of earnest money deposited by the tenderer will be refunded to him after he has applied for the same, in the manner prescribed by the ICAR-NIHSAD, Bhopal. An undertaking as per Annexure - II, is also required to be submitted by the tendering firm.
4. The schedules of the tender form should be uploaded with online technical bids. In the event of the space provided on the schedule form being insufficient for the required

purposes, additional pages may be added. Each additional page must be numbered consecutively and be signed in full by the tenderer. In such cases, reference to the additional pages must be made in the tender form. If any modification of the schedule is considered necessary it should be communicated by means of a separate letter along with the tenders.

5. The tenders are liable to be ignored if complete information as required is not given therein or if the particulars asked for in the schedules to the tenders are not fully filled in. Individual signing the tenders or other documents connected with the contract may specify whether he signs it in the capacity of (i) a sole proprietor of the firm/ constituted attorney of such sole proprietor, or (ii) a partner of the firm if it be partnership in which case he must have authority to refer to arbitration dispute concerning the partnership whether by virtue of the partnership agreement or power of attorney or (iii) constituted attorney of the firm if it is a company.
6. If a tenderer does not accept the offer, after issue of letter of award by ICAR-NIHSAD within 15 (Fifteen) days, the offer made shall be deemed to be withdrawn without any notice & earnest money forfeited.
7. In case of partnership firms, where no authority has been given to any partner to execute the contract/agreement concerning the business of the partnership, the tenders and all other related document must be signed by every partner of the firm. A person signing the tender form or any other documents forming part of the contract on behalf of another shall be deemed to warrant that he has authority to bind such other and if, on enquiry it appears that the persons so signing had no authority to do so, the ICAR-NIHSAD shall without prejudice to other civil and criminal remedies, cancel the contract and hold the signatory liable for all costs and damages. Each page of the tender and the schedules to the tender and annexure(s), if any, should be signed by the tenderer and should be uploaded along with technical bid.
8. Online tenders are invited under two bids systems through e-procurement system. **EMD must be deposited with Director, ICAR-NIHSAD during working hours i.e. 10:00AM to 5:00 PM on all working days (except Second Saturday, all Sundays and Gazetted Holidays) before the last date/time for submission of bids, failing which bids will not be accepted. EMD must be in the form of Demand draft/FDR in favour of ICAR Unit, NIHSAD, Bhopal.**
9. Tenders will be opened online by the authorized officer(s) on **13.07.2022 at 11:30 AM**. Bidders have two options to participate in tendering process at the time of opening of Bids. Bidders can come at the place of opening of bids (electronically) as done in the conventional tender process or he can visualize the process online without physically being present at ICAR-NIHSAD.
10. The financial bid (BOQ) will be opened for the technically qualified tenderers only. The date of opening of financial bid would be intimated to technically qualified tenderers.
11. Tenderer is at liberty to be present or to authorize a representative to be present at the time of opening of the tenders. The name and address of the representative who would be attending the opening of the tenders on your behalf should be indicated in your tender. Name and address of permanent representative of the tenderer, if any, may also be indicated.
12. An amount equivalent to 3% of the total contract value is to be deposited by the selected agency/successful tenderer as Performance Security Deposit only after receiving a communication from the NIHSAD. In the event of non-deposition of the same, the earnest money will be forfeited. The performance security will be refunded after 60 days of expiry of the contract, without any interest.
13. No interest on security deposit and earnest money deposit shall be paid by the NIHSAD to the tenderer.
14. The bid validity period is 180 days from the date of opening of technical bid.
15. **The current rates of wages and statutory contributions on person's wages as notified by the Central Govt. (Ministry of Labor, Govt. of India) for industrial workers in building operations will be paid and it will be further revised and paid by ICAR-NIHSAD, Bhopal from the dates of statutory revision in wages and statutory**

contribution from time to time as notified by the Central Govt. However, there will not be any increase in the service charges/other AMC charges quoted by the firm during the contract period. While the monthly rates of wages etc. will be considered for total value of the contract, the rates for the same shall not be quoted in the financial bid.

16. **The successful firm/bidder shall submit a notary affidavit on a stamp paper of appropriate value (Rs. 500/-) to the effect that the firm undertake to pay minimum rates of wages to the persons engaged as per applicable orders of Central Govt. (Ministry of Labour, Govt. of India) and to enhance the rates, as and when it is revised as well as the statutory contributions due w.r.t. VDA, EPF, ESI, etc.**
17. Any liability regarding payment of wages to the persons arising due to non compliance with any provisions of the Labour laws or due to any human loss/injury during the course of work will be the sole responsibility of the contractor.
18. **Monthly payment to the firm will be based on the payment of wages etc. as per actuals as per manpower provided, agency service charge, other AMC charges and GST as applicable. No other amount is to be retained by the service provider out of the minimum wages, EPF, ESI etc. as mandated by the statutory provisions on the subject. The applicable employer's share of EPF & ESI etc. will be paid to the contractor as per the latest guidelines issued by Ministry of Labour & Employment and EPFO on production of documentary evidence of depositing the share in the individual employee's EPF and ESI account.**
19. The firm/contractor shall nominate a coordinator for immediate interaction with NIHSAD staff/office as and when required.
20. **Weekly rest shall be provided to each worker engaged. A substitute shall be provided in case of any manpower absents himself. If substitute is not provided, daily rate of wages etc shall be deducted from the bill for the month. If the firm fails to provide a substitute within 3 days, a penalty clause will be imposed, besides deduction of daily wages.**
21. **The firm should be registered with EPF, ESI, Service Tax, Labour License (if applicable) & PAN with the concerned authorities & shall comply with all relevant laws & the rules made there under viz. Income tax, ESI Act, PF Act, Factory Act and Contract Labour act as notified by Central Govt./State Govt. from time to time.**
22. The Firm will not charge placement charges or any other account from the manpower deployed with NIHSAD from the payment to be made to the outsourced staff as per quoted rates. The contract is liable to be terminated, security deposit forfeited and the Contractor/Firm will be blacklisted if, at any stage, reports are received that the Contractor/Contracting Firm has charged the manpower on any account.
23. Income Tax (TDS) which is as per the rules of the Government shall be deducted at source from monthly bills of the successful tenderer, as per rules/instructions made applicable from time to time by government.
24. **In accordance with O.M. No. 29(1)/2014-PPD dated 28.01.2014 of Department of Expenditure, Ministry of Finance and order 31/14/1000/2014-GA dated 17.09.2014 issued by Ministry of Commerce & Industry, service charges/administrative charges quoted by the bidder necessarily has to be over and above zero percent of the total value of contract. Further, zero percent includes all derivatives of zero up to 0.9999 and there of. Any service charges not adhering to above guidelines shall be treated as unresponsive and will not be considered.**
25. Decision of Director, ICAR-NIHSAD shall be final for any aspect of the contract and binding on all parties. Disputes arising, if any, on the contract will be settled at his level by mutual consultation and in case of failure of settlement, dispute shall be referred to the sole arbitrator to be appointed by the Director, ICAR-NIHSAD. The decision of the sole arbitrator so appointed shall be final and binding on the parties. Arbitration proceeding shall be governed by the Arbitration & Conciliation Act, 1996 as amended from time to time.
26. Acceptance by the Director, ICAR-NIHSAD will be communicated by fax/e-mail or any other form of communication. Formal letter of acceptance and work order of the tenderer

will be forwarded as soon as possible, but the earlier instructions in the fax/e-mail etc. should be acted upon immediately.

27. The Director, ICAR-NIHSAD does not pledge itself to accept the lowest or any tenders and also reserve to itself right of accepting the tenders whole or in part keeping in view valid reasons. Conditional tenders will not be accepted.
28. The Director, ICAR-NIHSAD in its capacity as Principal Employer, reserves the right to modify any of the terms and conditions of the contract as mentioned in the Schedules I & II of this document, at its discretion, in the interest of the tender.
29. Successful Bidder/tenderer will have to enter into a detailed contract agreement with ICAR-NIHSAD on non-judicial stamp paper of Rs. 500/- (Five Hundred Only) for providing AMC service.
30. **Tender process: -**
- 30.1 Tender is in two parts i.e. (i) Technical bid and (ii) Financial bid. Both technical and financial bids duly filled shall be submitted online on CPP portal.
- 30.2 Technical bid must contain the scanned copy of EMD and all other documents called for in the tender.
- 30.3(a) **Technical Bid:-**
  - i. This shall contain the entire tender documents except the financial bid with each page signed with the rubber stamp of the bidder.
  - ii. **Scanned copy of experience certificates of AMC service for operation and maintenance of PLC AND STEAM BASED LIQUID WASTE STERILIZATION PLANT & ASSOCIATED ACCESSORIES for atleast 2 works of one year duration each during last 5 years (2017-2022) in Govt./PSU/Autonomous bodies/Reputed Process Industries/pharmaceuticals industries or Agency/Firm manufacturing biologicals for animal/human use. (All relevant experience certificates from the service recipient institute/organization/agency/firm shall be uploaded however, copy of work order will not be considered as experience certificate & details to be provided as per format (Annexure I)).**
  - iii. Scanned copy of DD/FDR of earnest money deposit (EMD), if not in exempted category.
  - iv. Scanned copies of MSME/NSIC (in related service/business), if applicable. The MSME/NSIC firms are exempted from EMD subject to submission of their valid registration certificate as per the stipulation of Central Government.
  - v. Scanned copy of Registration Certificate of the bidder/agency/company/sole proprietor/partnership firm from the appropriate authorities of Govt. to carryout business in relevant area. In case of partnership firms, a scanned copy of the partnership agreement to be uploaded.
  - vi. Scanned copy of audited balance sheet of the firm by the Chartered Accountant to fulfill the requirement of minimum annual average turnover of the firm not less than Rs. 20,00,000/- (Rupees Twenty Lakhs Only) during the last three financial years.
  - vii. Scanned copies of EPF and ESI registration certificate issued by an appropriate authority.
  - viii. Scanned copy of documentary proof of numbers of Staff registered under ESI & EPF separately.
  - ix. Scanned copies of valid GST registration certificates issued by competent authority. (If GST is not applicable as per GOI rules, an undertaking on company letter head shall be submitted)
  - x. Scanned copies of valid PAN Number and scanned copy of Income tax Returns for the last three financial years.
  - xi. Scanned copy of valid labour license issued by an appropriate authority under the Contract Layout (Regulation & Abolition) Act, 1970 and Contract Labour (Regulation & Abolition) Rules, 1971. **(If labour license is not applicable, an undertaking in this regard shall be provided).**
  - xii. Scanned copy of an undertaking as per attached Format (Annexure – II) duly attested by Notary on a non-judicial stamp paper of value of Rs. 500/- (Rupees Five Hundred Only) regarding their non-blacklisting by any of the Government Departments, Public Sector

Undertakings and/or by Central Vigilance commission during the last three years. **Original undertaking should be submitted along with EMD to the Director, NIHSAD, Bhopal.**

30.3(b) **Financial bid:-**

This shall contain the schedule of rates duly filled and signed in the prescribed format (BOQ).

Bids quoting NIL/unfeasible agency/other AMC charges will be treated as unresponsive and will not be evaluated. Financial bid (BOQ) should be uploaded separately.

31. **Evaluation of bids**

**a. Technical bid evaluation**

- (i) Evaluation of technical bid will be done as per the minimum essential qualification of the bidder and submission of all essential documents required for the tender.
- (ii) Only those bidders who qualify in the technical bid will be considered for opening and evaluation of financial bid

**b. Financial bid (BOQ) evaluation:** Guidelines for filling financial bid and evaluation of financial bid criteria are mentioned below:

- (i) Since the monthly rates of wages including VDA & statutory contributions (EPF, ESI etc.) and applicable GST on the taxable items will be paid as per actuals as per the Govt. of India rules and will be same for all, there is no provision in the BOQ for filling the rates for wages and GST.
- (ii) **Hence, the bidder shall quote other AMC charges per month (Sr. no. 1.01), and the Agency service charges per month (Sr. no. 1.02) only exclusive of GST. Such rates quoted by the firm in the financial bid shall be commensurate with the scope of work/service under AMC, administrative & supervisory efforts required for executing the contract.**
- (iii) **If any firm quotes the Agency service charge as zero/Nil as defined in Sr. no.24 (Page.5) or other AMC charges is unfeasible as per the scope of service/work under contract, it will be treated as a invalid quote and rejected even though the firm/bid is otherwise technically qualified.**
- (iv) **The financial bid of the responsive bidders will be evaluated and L1 bid will be decided on the basis of total value of monthly rates of other AMC charges & Agency Service charges only.** However, the monthly rates of wages including statutory contributions and applicable GST etc. will be considered for estimating total value of the contract.
- (v) In case of a tie in financial evaluation, the firm having more experience/Performance of supplying similar services in Central/State Govt./PSU's/Autonomous bodies shall be considered for the award of contract.
- (vi) **As per the current rates of wages and statutory contributions on person's wages as notified by the Central Govt. (Ministry of Labor, Govt. of India) for industrial workers employed in building operations (F.NO. 1/4(3)/2022-LS-II Dated 31.03.2022) applicable w.e.f. 01.04.2022, the rate of wages per day including VDA for 1 skilled worker is Rs. 734/- plus all statutory contribution as applicable and rate of wages per day including VDA for 1 semi-skilled worker is Rs. 625/- plus all statutory contribution as applicable shall be paid. The currently applicable rates of wages and statutory contribution will be paid and it will be revised & paid subsequently by ICAR-NIHSAD, Bhopal whenever it is revised & notified by Ministry of Labour, Govt. of India during the contract period.**

Each work point shall be manned for 24/26/27 days in a month for minimum 8 hours (9 A.M. to 5 P.M. or 10 A.M. to 6 P.M.) as per the instructions of NIHSAD. The skilled staff shall be responsible for overall supervision & functioning of entire system under contract.

##### **(a) Work point with requirement of supervisory work (Skilled) – 01 No. –**

**Qualification:** Diploma/B.E./B.Tech. in Electrical/Electrical & Electronics/Electronics and Communication/Mechanical/Instrumentation Engg. with atleast 3 years of experience in similar process plant as per Schedule-II, 1.1.

##### **(b) Work points with requirement of operator cum mechanic (Semi-skilled)-04 Nos. –**

**Qualification:** ITI in Electrical/Electronics/Mechanical/Fitter/Instrumentation/PPM (Process Plant Maintenance) Trade with NCVT certificate having atleast two years of experience in similar process plant as per Schedule-II, 1.1.

##### **(c) Besides the above contractual staff, the other casual contractual manpower/technician/technical expert shall be provided by the bidder as & when required under the scope of service/work.**

### **2.2 PROVISION OF UNIFORM AND SAFETY GADGETS ETC.:-**

**2.2.1 Providing Personal Safety Equipment, working tools, jigs and fixtures:** All the tools and tackles, welding machines, safety gadgets (safety Helmets, ear mufflers, hand gloves, eye goggles, Gum boots, Industrial safety shoes etc.) to be provided by the successful bidder to their staff at NIHSAD site. All the contractual staffs will be provided by the contractor at least one pair of shoes and two sets of uniform (dungaree/ overall combination) of blue colour on Annual basis (colour shade sample will have to be produced to the Competent Authority for acceptance). The logo and name of the firm should be embroidered in uniform along with the Identity card. Appropriate cost for providing uniform etc. should be taken into account while quoting the other AMC charges in the financial bid. No employee will be replaced/changed without the consent/intimation of the NIHSAD's Authority. No contractual staff shall be allowed to work without uniform & prescribed safety gadgets.

### **2.3 Other Terms & Conditions:-**

**2.3.1** NIHSAD will not be responsible for any injuries, accident to the contractor's employees which may occur during the course of operation/ negligence in performing the duty.

**2.3.2** The contractor or its authorized representative shall have to be in regular touch at least once in a week either with Admin Officer and concerned Engineer/Engineering In-charge for any suggestion/ requirements.

**2.3.3** No contractual staff will be replaced/changed without the consent/intimation of the NIHSAD's Authority.

**2.3.4** Two men safety rule shall be followed all the time in liquid sterilization (ETP) plant area.

**2.3.5** Contractor should deploy contractual manpower in such a way that all of their staff gets weekly off, and other paid holidays like 26 January, 15 August and 2nd October. At least 2 nos. of staff should be available for preventive maintenance of ETP during Sunday and holidays except National Holidays.

**2.3.6** Whenever a technician/expert is hired, the firm should inform NIHSAD in writing giving their name address and phone number well in advance.

**2.3.7** The service provider shall maintain logbooks for all maintenance & repair work under its care and all complaints and jobs taken care shall be recorded. These books shall be shown to NIHSAD authorities as & when required.

- 2.3.8 The manpower deployed for executing the Job shall also be utilized by NIHSAD for any other work of similar nature.

## 2.4 **PLC AND STEAM BASED LIQUID WASTE STERILIZATION PLANT & ASSOCIATED ACCESSORIES**

- 2.4.1 Process Description:-** The contaminated liquid waste/water from the containment laboratory and animal wing is to be sterilized at 2.5 kg/cm<sup>2</sup> pressure, 121°C for 30 minutes before its release from the containment area. The minimum of 15 M<sup>3</sup> will have to be sterilized daily. In case the effluent is more, then the system shall run till the effluent is processed completely. If the need arises then even the systems shall run on Sunday/Holidays/National Holidays. The work also involves the maintenance/repairs of the Plant/Instruments/PLC/Piping (SS/HDPE/MS)/ Tanks/Pumps/ Macerators/ Control valves including complete piping in the liquid waste sterilization plant coming from the ceiling of ground /1st floor.

#### 2.4.3 **Operation:-**

As the basic purpose of ETP is to prevent the escape of pathogens from the laboratory to the environment through liquid waste, the system should run without any fail. The readings are to be recorded on daily basis in the log book made available by NIHSAD while operating under semi-automatic mode for each sterilizer.

#### 2.4.4 **Maintenance:-**

- Repair & maintenance of all piping systems carrying air, water, steam associated with liquid waste sterilization plant (like airline and associated valves, steam traps etc. within the liquid waste sterilization plant area) including sterilized effluent pipe line upto the lagoon area (outside the inner boundary): **As & when required**
- Cleaning of choked HDPE Pipe line from lab outlets to storage tanks: **As & when required**
- Maintenance of safety valves (14 Nos.) and Steam Traps (14 Nos.): **On Quarterly basis**

#### 2.4.5 **Preventive Maintenance (ETP) :-**

##### (a) **Daily Checks:**

- Visual inspection of leakage of effluent from the pipe lines (Entire HDPE and SS pipe line, flanges, elbows, P traps etc.) coming out from the ceiling of basement floor.
- Visual inspection of any leakage of effluent from the sterilizers, storage tanks, mixing tanks, pumps associated with liquid waste sterilization plant.
- Visual inspection of Electricals control panel, cable terminations, motor terminals for any loose connections, carbon deposition etc.
- Records of sterilization temperature and time for each cycle.

##### (b) **Weekly Checks:**

Checking of all probes, sensors, thermo wells alongwith their terminals.

##### (c) **Monthly Checks:**

All P/S traps alongwith their flange connections are to be checked and cleaned for clearing of blockage.

- Maintenance of Logbook:-** Logbooks are to be maintained by the service provider. Record & maintenance of logbook are to be kept chronologically along with record of preventive work, breakdown maintenance etc.

#### 2.4.6 **Hydraulic Testing:-** Hydraulic testing of sterilization tanks (6 nos.) as per BIS specification or 1.7 times the working pressure from NABL/State Govt./ Central Govt. agency and report shall be submitted: **Once in a year**

**2.4.7 Calibration:-** Calibration of total 43 number of instruments (Digital level indicator & controller 07 nos.; PID controller 06 nos.; Temperature transmitter 16 nos.; Pressure switch 06 nos.; Pressure transmitter 06 nos.; Digital temperature recorder 01 no.; Digital pressure recorder 01) shall be done through NABL approved external agencies with duly certified standard test instruments and equipments. Calibration reports shall be submitted after calibration: **Twice in a year**

**2.4.8 De-rusting & painting:-** De-rusting & Painting of pump base/cable trenches with red oxide/enamel paint: **Once in a year**

## **2.5 PLC based Shower Control system-**

**2.5.1 Preventive Maintenance:-** The following maintenance work shall be carried out:

- i. Checking the function of PLC system, electronic latches with sensors & SCADA system.
- ii. Daily maintenance work pertaining to PLC based Shower Control System etc. as per the direction of NIHSAD.
- iii. Trouble shooting of faults if any.
- iv. Quarterly servicing of valves, push buttons, electronic latches, sensors etc.
- v. Checking of wiring and all cable connectors.
- vi. **PLC based Shower system shall be tested for optimal functioning by hiring competent technical personnel from authorized service agencies and service report shall be submitted: Once in a year**
- vii. In case of any major fault in shower system and for rectification if technical personnel (Technician/Engineer) is needed then the visit charge of technical personnel from authorized agencies along with welding and machining work, if any shall be in the scope of bidder, whereas all major spares/consumables shall be provided by the NIHSAD.

## **2.6 Spares & Consumables:-**

**2.6.1 Spares under NIHSAD Scope: -** All the spares of instruments/ equipments/ gauges/ LT fuses/ coils/ relays/SS pipe & fittings/electrical contactors/ pumps spares required for maintenance/repair would be provided by NIHSAD. The contractor has to give the list of spares required for repair well in advance.

**2.6.2 List of consumables & other items under scope of the service provider:-**

- i. All types of nut bolt (SS & MS), washers, teflon gasket, gland rope, rubber bush, teflon tape, toughened glass for sterilizer tanks, insulation tape, M-seal, RTV sealant, all type of cable lugs, glass fuses, V belts etc.
- ii. Grease and gear oil.
- iii. Rewinding and repairing of motors (material, labor charges and transportation all inclusive).
- iv. All type of machinery and welding work.

**2.6.3 Repair of equipments:-**

Equipment which cannot be repaired at site is to be got repaired from the manufacture or their authorized service agent by the bidder. For repair, only the cost of spare parts/ replaced parts plus taxes on it will be reimbursed by NIHSAD. But the transportation charges & repair charges plus taxes if any will be borne by the bidder.

## OTHER TERMS & CONDITIONS

1. The contract is subject to the condition that the tenderer will comply with all the laws and acts of Central Govt./State Govt. relating to this contract made applicable from time to time.
2. The persons so provided by the agency under this contract will not be the employee of the NIHSAD and there will be no employer-employee relationship between the NIHSAD and the person so engaged by the contractor in the aforesaid services.
3. For this Contract, water and electricity will be provided by the institute. It is presumed that the bidder has assessed all the requirements of manpower/materials/logistics/taxes etc. thoroughly before participating in the tender process. None of the other requirements including stationary items would be provided from the institute.
4. The contractor will discharge all his legal obligations in respect of the workers/supervisors to be employed/deployed by him for the execution of the work in respect of their wages and service conditions and shall also comply with all the rules and regulations and provisions of law in force that may be applicable to them from time to time.
5. The contractor shall indemnify and keep indemnified the NIHSAD from any claims, loss or damages that may because to it on account of any failure to comply with the obligations under various laws. In case of any dispute the decision of Director, NIHSAD shall be final and binding on the contractor.
6. The service provider/contractual staff should have adequate literary knowledge to cope up with the smooth operation of work.
7. The firm/contractor shall nominate a coordinator for immediate interaction with NIHSAD staff/office as and when required. Weekly rest shall be provided to each worker engaged.
8. The contractor must employ adult contractual staff (21 – 58 years) only. Employment of the child labour shall lead to the termination of the Contract.
9. Any change in contractual worker should be done in consultation with NIHSAD authority. Abrupt and unjustified changes will not be accepted.
10. All the Contractual Staff should follow strict attendance and alternative arrangements are to be made by the agency to keep all the work points to be in operation by the substitute if any contractual worker leaves the point.
11. The agency shall employ good and reliable Contractual persons with good health. In case any of the personnel so provided is not found suitable by the NIHSAD, the NIHSAD shall have the right to ask for his replacement without giving any reason thereof and the agency shall on receipt of a written communication will have to replace such persons immediately.
12. The contractor shall not sublet the AMC services to any other agency.
13. The contractor or his workers shall not misuse the premises allotted to them for any purpose other than for which the contract is awarded.
14. The contractor shall keep a complaint register with his nominated coordinator, and it shall be open to verification by the authorized officer of NIHSAD for the purpose. All complaints should be immediately attended by the Agency.
15. All the contractual workers should maintain discipline, punctuality and obedience in the campus. Any misconduct would entail the administration to instruct the contractor to replace the person immediately.
16. The service provider shall be fully responsible for theft, burglary, fire of any mischievous deeds by his worker/staff engaged at NIHSAD.
17. The contractor may have to deploy additional maintenance worker depending upon the requirement of maintenance work in addition to minimum manpower as mentioned above without any cost to NIHSAD.
18. The firm/agency/contractor shall keep the equipment well maintained, neat and clean and adhere to the operation and maintenance schedule of various equipments.
19. Payment to the Contractor will be made on monthly basis. The sequence of payment would be as given below:-
  - a. Payment to the contractual staff shall be done by the contractor through BANK TRANSFER in their account on or before 10<sup>th</sup> of each month
  - b. **Monthly payment to the firm will be based on the payment of wages and statutory**

**contributions etc. as per actuals as per manpower provided, agency service charge, other AMC charges and GST as applicable. No other amount is to be retained by the service provider out of the minimum wages, EPF, ESI etc. as mandated by the statutory provisions on the subject.**

- c. The contractor shall submit the claims of such payments to the institute alongwith proof of bank transfer, attendance sheet of contractual staff engaged, payment towards EPF, ESI, GST and other statutory payment etc. The mode of payment and challans etc. should be transparent so as to prove their authenticity.
  - d. Upon verification of records as mentioned above the administration would release the payment via BANK TRANSFER to the Bank account of service provider.
  - e. In no case, release of payment should be linked to payment to contractual workers which must be done before 10<sup>th</sup> day of each month.
  - f. Income Tax (TDS) will be deducted from the payments due for the work done as per prevailing rules of Govt. of India.
  - g. The contractor will have to provide the details of (individual wise) EPF deposition with the concerned department and copy of the detailed list obtained from the EPF department/website should be submitted as a supporting document alongwith the bill of the succeeding month.   - h. **The contractor will have to give revised minimum wages with other statutory liabilities as and when the minimum wages are revised during the period of the contract. The rates of wages and statutory contribution on person's wages will be revised and paid by ICAR-NIHSAD from the dates of statutory revision in wages and statutory contribution as notified by the Ministry of Labour, Govt. of India from time to time. However, there will not be any increase in the service charges/other AMC charges quoted by the firm during the contract period. While the monthly rates of wages etc. will be considered for total value of the contract, the rates for the same shall not be quoted in the financial bid.**
  - i. The Institute will not be responsible either to the Contractor or to its workers deployed at this Institute for any medical assistance/injuries/death or any kind of loss occurred to contractual labour.

**INSTRUCTIONS TO CONTRACTOR FOR STATUTORY COMPLIANCES FOR AMC  
SERVICE CONTRACT**

- 1.0 Statutory registration and clearances**  
Contractor shall commence the work only after obtaining valid Labour License (if applicable), independent provident fund no., ESI Registration no., PAN no., GST registration no. and clearance certificate in respect of provident fund, ESI and Income tax from respective enforcement authorities.
- 2.0 Identity Card**  
Contractor shall provide to each of his employee an Identity card which shall have his photograph verified by contractor, his name, place of work and name of the contractor
- 3.0 Statutory obligation**
  - 3.1 Contractor shall engage only adult workers (in the age group of 18 years and 58 years).
  - 3.2 Contractor shall observe all local laws applicable.
  - 3.3 In case a contractor deploys women worker, obligation under women's law – should be followed.
- 4.0 PF & ESI Contribution & Return**
  - 4.1 PF & ESI contribution of workers engaged shall be borne by the contractor as per laws/ rules in force & shall produce papers/ records whenever asked to do so.
  - 4.2 Contractor shall fully comply all other formalities as per the PF & ESI statutory provisions and submit a copy of the challan etc. to NIHSAD for replying to statutory authorities in case of any complaints.
- 5.0 Police verifications:** - Verification of the character and antecedents of all contractual workers from police authorities are to be got done by the contractor and relevant documents shall be submitted to the office within one month of commencement of AMC.
- 6.0 Medical care in case of accident**
  - 6.1 The agency shall agree to get all the staff members insured against any liabilities arising under the workman's compensations act or under the common law. This aspect shall not be a liability on the part of the Institute in any case.
  - 6.2 It is responsibility of contractor to undertake necessary care and make arrangement for transportation and the treatment of his worker.
  - 6.3 Contractor should assist and guide his workers.
- 7.0 Supervision**

Name and address of the Supervisor shall be submitted to the concerned department by the contractor.
- 8.0 Payment of wages**  
Payment shall be made by the contractor to his workers as per their category & nature of work which shall not be less than the rates declared from time to time under Minimum wages Act. As per Central Govt.

**9.0 Safety and disciplinary action**

Contractor shall ensure that his workers do not indulge in any unsafe or hazardous activities. They use safety equipment such as safety belts, safety shoes, goggles, helmet and masks where use of such equipment is required in day-to-day operations. All such safety gadgets will be provided by the contractor.

**10.0 Records & information to be furnished by contractor**

10.1.1 Contractor shall maintain neatly, completely and legibly registers, records, reports and returns for inspection by various authorities at short notice.

10.1.2 Contractor shall provide full particulars of each worker deployed by him before start of the work from time to time.

**11.0** After award of AMC the successful bidder has to deposit 3% performance security with agreement before starting the work. In case of a new contractor taking over AMC, the new contractor has to depute his staff to acquaint with the working of the machinery at least 15 days before actual taking over the work. He will not be allowed to start work before the agreement signing, payment of the security deposit etc.
