2. Tenderers/bidders are requested to visit the website <https://eprocure.gov.in> regularly. Any changes/modifications in tender enquiry will be intimated by corrigendum through this website only.
3. In case, any holiday is declared by the Government on the day of opening, the tenders will be opened on the next working day at the same time. The Director, ICAR-NIHSAD reserves the right to accept or reject any or all the tenders.
4. The interested Firms are required to deposit (in original) the Earnest Money Deposit (EMD) of the amount mentioned against item in the form of Account Payee Demand Draft/FDR from any of the Commercial Banks in favour of **ICAR Unit, NIHSAD, Bhopal** payable at Bhopal may be addressed to Director, ICAR-NIHSAD, Bhopal – 462022. The EMD can also be deposited online in an acceptable form on or before bid opening date and time as mentioned in the Critical Date Sheet. In case of depositing the EMD through online mode, proof of EMD (UTR No or any other) must be submitted alongwith tender. No quotation shall be considered without the earnest money deposit. **Annexure – II****Terms & Conditions**

1. The tenderer shall quote rates, which will include the delivery & other incidental charges. Taxes etc. should be indicated separately.
2. The rates should be quoted as per the BOQ uploaded on the CPP Portal (reference may be obtained from Annexure – III). Taxes, if any, should be indicated separately. It must be noted that the contract shall be awarded to the firm which fulfills all the required terms and conditions and remains L-1 for any particular items.
3. The firm must also possess valid PAN No., GST No. registration number and a copy of the same must also be enclosed with the tender documents.
4. The Bio-containment Individually ventilated cage system with fittings quoted should be of latest technology. The spare parts of the Bio-containment Individually ventilated cage system with fittings quoted should be available for next 10 years.
5. Modification in the tender documents after the closing date is not permissible.
6. The successful firm shall have to supply the Bio-containment Individually ventilated cage system with fittings within 30 days from the date of confirmed supply order and if the materials are not supplied in time then EMD shall be forfeited. **The rates quoted shall be valid for One Hundred & Eighty days (180) from the date of opening of tender.**
7. The contractor bidder/ or his representative may contact the undersigned at Tel No. 0755-2750647, 2757542 for any further clarification between office hours. No variation in terms of quality of the items shall be entertained or else EMD/Security deposit shall be forfeited.
8. The Director, ICAR-NIHSAD shall have the right to reject all or any of the offers, accept more than one offer, and assign part of the job.
9. Merely quoting of lowest rates does not mean that order shall be given to that firm. The competent authority will finally decide on the basis of quality & performance or past installations.
10. Rates once finalized will not be enhanced/reduced during the currency of the contract.

## ANNEXURE – VII

### **TECHNICAL SPECIFICATIONS**

#### **Bio-containment individually ventilated cage system with fittings**

**General:** Supply, Installation, Testing and Commissioning of “Mobile, Individually Ventilated Caging Systems (IVC) for housing rats/ guinea pigs /hamsters and respiratory virus challenged animals under negative bio-containment conditions with bottle type drinking water arrangement.

#### **Air Handling Unit-**

1. Stand-alone type, capable of handling a minimum of 24 to a maximum of 48 cages.
2. HEPA filters and pre filters should be fitted on both supply and exhaust systems of AHU and the efficiency level of the filter should be 99.999 % to prevent the entry of particles of more than 0.3micron size. HEPA filters should be DOP tested.
3. Air handling unit of the BCU should provide minimum 60 or more Air change/ hour.
4. The system should have built in safety devices/ alarm indicating system failure, filter choking etc. It should have ability to signal alarms when temperature and relative humidity, supply airflow, exhaust airflow, air pressure etc., conditions set up by operator are breached. There should be a mechanism whereby a SMS and email is received indicating system failure. Or software supported system to retrieve data with help of external device like pendrive etc.
5. Provision for real time display of critical parameters like temperature, relative humidity, number of air changes per hour (ACH) etc. Also display HEPA life indicator as “%age” for HEPA filter life.
6. There must be a provision to discharge the exhaust HEPA filtered air out of the room via a thimble connection directly with the room exhaust. All the fittings and workmanship for the same will be in the scope of supplier. All the joints should be sealed airtight with silicon or equivalent sealant. The exhaust connections need to be tested for any leakages on site. All the relevant tests need to be done in the presence of technical team of the institute.
7. The IVC system should be capable of providing constant high negative pressure inside the cage to provide safe environment for the operators.
8. Noise level generated by the equipment should be less than 50 dBA.

#### **Cages and Bottles: (A minimum of 48 to be included in the quote)**

1. Cages should be made of Polysulphone material with clarity/transparency capable of bearing frequent autoclave cycles. Caging accessories like cover grills, water bottles, label holders etc. should be included.
2. The cages including bottle fittings should be hermetically sealed appropriately to prevent leakage of air. Cages should be demonstrated to be leak proof during onsite installation.
3. There should be a Visual Indicator or mechanism whereby operator can immediately see if the cage is properly in place on the rack.

4. Cages should come with gasketed self-closing nozzles so that as soon as cage is removed from the rack it remains pressurized for a long time to ensure safety and protection for operators.
5. Cages should have a floor space as per national/ international recommendations for housing rats/ guinea pigs/ hamsters–and appropriate air filter/safety feature for animals to permit filtered air exchange in case of any system/power failure.
6. Cage should be fitted with HEPA filters with efficiency of at least 99.97% at cage level to ensure maximum safety for the personnel during procedures or in case of power failure.

#### **Racks:**

1. Capacity of Minimum 24 and maximum 48
2. Racks should be of Stainless Steel AISI 304 or better material, fully autoclavable (amenable to sterilization or decontamination)
3. Automatic cage lock system
4. Rack must be mobile with foot operated brakes on wheels
5. The BCU design should be compact in such a way that, it can be placed in the said animal room or the final assembly of BCU may be done inside the room. (Compatible dimensions – maximum 6ft length, 25 inch width and 6ft height)
6. There should be 2 Blowers one each at supply and exhaust in case of blower failure
7. BCU-with analog/manual mode so that system can be used in case of PLC error.
8. Battery backup (Inbuilt) with for at least 10hrs uninterrupted power supply OR an UPS to be supplied along with the unit with 10hr backup for 200 watt load.
9. Card holder fitting to give visibility of animal inside the cage.
10. Voltage compatibility in the range of 180-264V or supplied with a compatible voltage stabilizer, 50/60 Hz
11. Power consumption within 200watts preferably with DC
12. Noise less than 50 dBA
13. Audible Alarm Option, trigger on blower & power fail

#### **Accessories**

1. Single sided bedding disposal unit (maximum length 3ft) should be included as an accessory which should ensure operator protection from airborne particulates generated during bedding disposal operation. Room air should be drawn into the front working area of hooded enclosure, preventing aerosols from escaping into the room. The contaminated air should be exhausted through the HEPA filtered exhaust ensuring environment protection. The attached waste gallon should preferably be with castors.
2. Replacement HEPA filters for the air exhaust and supply unit – 3 set spares each
3. Replacement micro barrier filter or pre-filter sheet or device (100 replacements) for the individual cage.
4. Water bottles- 10 extra than the supplied number
5. Cages - Extra 6 than the supplied number

#### **Installation and Commissioning**

1. The equipment must be fitted into the existing HVAC system and if necessary thimble and duct to be attached to the available HVAC system (room size: (LxBxH= 17ft x 18ft x 11ft) one supply and exhaust in the room with (450X450 mm) of approx. available blower capacity 480 cfm
2. Zero leakage at the ventilator level to be ensured
3. Onsite tests and compliance of the equipment for validation
  - i. Smoke test for the correct airflow
  - ii. Differential pressure test across the HEPA filters
  - iii. Vibration level test of the equipment if required.
  - iv. Noise level test of the equipment

**Other terms and conditions**

1. *Warranty for 2 years*
2. *Performance certificate and a list of at least 3 customers should with at least one supply to BSL3 lab be included*
3. *The vendor should have at least 10 years' experience of manufacturing & supply of IVCs.*
4. *Annual Maintenance cost for five years beyond the warranty period also to be quoted for the Bio-containment IVC system*
