1. Quotation should be submitted under two bid system in a separate envelope (Technical Bid + Financial Bid) clearly mentioning at the top Tender No F. No. 9-102/20-21/NIHSAD (P&S) "Painting Work of 132 Nos. Electrical Street Light Poles of NIHSAD" and EMD particulars. The Technical bid and the Financial bid should be sealed in separate envelopes and both these sealed covers are to be put in a bigger cover which should also be sealed. The last date of receipt of above quotation is 19.07.2021 Upto 5:00 PM. The Institute will not be responsible for any postal delays.

- The rates should be quoted for F.O.R. ICAR-NIHSAD, Bhopal basis as per quotation based on the scope of work & quality of materials.
- 3. Discount, if any, should be indicated clearly.
- 4. This Institute is registered with the Department of Scientific & Industrial Research (DSIR), Govt. of India for purpose of availing custom duty exemption in terms of Government. Notification No. 51/96-Customs dt. 23.07.1996, amended by Notification No. 4312017 dated 30.6.2017, Notification No. 47/2017-Integrated Tax (Rate) dt. 14.11.2017 and Notfn. No.'4512017- Central Tax (Rate) dt. 14.11.2017. Notfn. No. 45/2017- Union Territory Tax (Rate) dt. 14.11.2017. However, as per notification No. 45/2017-Central Tax (Rate) dated 14.11.2017 issued by the Min. of Finance, Scientific and Technical instruments, etc. are exempted from the Central tax (in excess of 2.5%) livable there on under section 9 of the Central Goods and Service Tax Act, 2017 supplied to the Departments & laboratories of the Central Government and State Governments, other than a hospital. - 11. In all matters of disputes, the decision of the Director of this Institute shall be final and binding.
- 12. Maximum period of completion of work is 45 days.
- 13.TDS will be deducted from the bill as per applicable tax rules.
- 14.Payment terms: Payment will be made reasonable time say within 30 days from the date of receipt of material in good condition without any damage and after installation of the equipment in accordance with the ordered specification at the end. Since the mode of payment will be e-payment system, hence, Bank Account, Number, Name of Bank with location and IFSC code Number of Bank may be furnished on the body of the bill.

- Remove rust of all street light poles (Round single bracket, Round double bracket, Round pole top latteren, Rail pole and Gate pole) along with junction box by proper rubbing with emery paper. iii.
- After removing rusting of all poles, the contractor should check all the poles with electrical In-charge. IV.
- After checking all the poles, the street light poles shall be painted with two coats of red oxide primer (Asian/Nerolac/Burger) and then two coats of silver aluminum paint (Asian/Nerolac/Burger) over them. The Junction box of street light poles be painted with Smoke Grey colour (Asian/Nerolac/Burger).
- All street light pole foundation (RCC) shall be painted with two coats of white distemper (Asian/Nerolac/Burger).
- The marking of all streets light poles shall be such that the black color Vi. numeric digits lie within the Yellow color circle. vii.
- The paining work shall be executed only in dry weather conditions. viii.
- The bidder may visit the site before quoting.
