Relevant & Other Terms & Conditions are as below: -

- 1. **Eligibility of Technical Bid-** The firm must also possess valid PAN no., GST certificate and valid firm registration and a copy of the same must also be enclosed with the tender documents.
- 2. The rates should be quoted for F.O.R. ICAR-NIHSAD, Bhopal basis as per quotation based on the scope of work & quality of materials.
- 3. Discount, if any, should be indicated clearly.
- 4. This Institute is registered with the Department of Scientific & Industrial Research (DSIR), Govt. of India vide its Registration Certificate No. TU/V/RG-CDE/1235/2019dated 01.09.2019. Hence, GST may be charged accordingly.
- 5. The rates quoted should be valid for 180 days from the date of opening of quotation.
- 6. There should be no cutting/overwriting in the quoted rates.
- 7. Warranty -01 year from the date of supply/completion of work.
- 8. Unattested/amended/overwritten figures will not be considered.
- 9. Rates should be inclusive of all required materials and labour.
- 10. In all matters of disputes, the decision of the Director of this Institute shall be final and binding.
- 11. Maximum period of completion of work is 20 days.
- 12. TDS will be deducted from the bill as per applicable tax rules.
- 13. Payment terms: Payment will be made reasonable time say within 30 days from the date of receipt of material in good condition without any damage and after installation of the equipment in accordance with the ordered specification at the end. Since the mode of payment will be e-payment system, hence, Bank Account, Number, Name of Bank with location and IFSC code Number of Bank may be furnished on the body of the bill.
- 14. Payment will be done after joint inspection as per actual measurement.
- 15. If the firm's representative works to visit at site premises then he will be allowed in working hours. However the visit is not mandatory.
- 16. The agency shall agree to get all the workers insured against any liabilities arising under the workman's compensations act or under the common law. This aspect shall not be a liability on the part of the Institute in any case. It is responsibility of contractor to undertake necessary care and make arrangement for transportation and the treatment of his worker.
