Online Tender are hereby invited on behalf of the Director, ICAR-NIHSAD, Bhopal for AMC of Operation & Maintenance of LAN/WAN/COMPUTER ETC.(ON COMPREHENSIVE BASIS) FOR A PERIOD OF ONE YEAR ON WORK CONTRACT BASIS AT ICAR-NIHSAD, BHOPAL AND EXTENDABLE BY ONE MORE YEAR SUBJECT TO SATISFACTORY PERFORMANCE OF THE VENDOR AND MUTUAL AGREEMENT.

- 1. The terms and conditions of the contract are those contained in the general conditions of contract applicable to the contracts placed by the ICAR-NIHSAD as detailed in the tender forms and its schedules. Please submit your rates in the tenders form if you are in a position to furnish the requisite services in accordance with the requirements stated in the attached schedules.
- 2. Earnest money of Rs. 10,000/- and Rs. 1,000/- (only DD) as cost of Tender form must be deposited in the form of demand draft/FDR to ICAR Unit, NIHSAD, Bhopal in person to Director, ICAR-NIHSAD, Bhopal on or before the last date/time of submission. The particulars of the earnest money deposited must also be superscribed on the top of the envelope by including the demand draft/FDR number and date failing which the bids will not be accepted. Conditional bids shall not be considered. No overwriting or cutting is permitted in the tender documents. Such bids will be rejected outright.
- 3. The tenderer is being permitted to give tenders in consideration of the stipulations on his part that after submitting his tenders, he will not resile from his offer or modify the terms and conditions thereof. If the tenderer fails to observe and comply with the foregoing stipulations, the aforesaid amount of EMD will be forfeited by the NIHSAD. In the event of the offer made by the tenderer not being accepted, the amount of earnest money deposited by the tenderer will be refunded to him after he has applied for the same, in the manner prescribed by the ICAR-NIHSAD, Bhopal. An undertaking as per Annexure II, is also required to be submitted by the tendering firm.
- 4. The schedules of the tender form should be uploaded with online bids. In the event of the space provided on the schedule form being insufficient for the required purposes, additional pages may be added. Each additional page must be numbered consecutively and be signed in full by the

- tenderer. In such cases, reference to the additional pages must be made in the tender form. If any modification of the schedule is considered necessary it should be communicated by means of a separate letter alongwith the tenders.
- 5. The tenders are liable to be ignored if complete information as required is not given therein or if the particulars asked for in the schedules to the tenders are not fully filled in. Individual signing the tenders or other documents connected with the contract may specify whether be signs it in the capacity of (i) a sole proprietor of the firm of constituted attorney of such sole proprietor, or (ii) a partner of the firm if it be partnership in which case be must have authority to refer to arbitration dispute concerning the partnership whether by virtue of the partnership agreement or power of attorney or (iii) constituted attorney of the firm if it is a company.
- 6. If a tenderer does not accept the offer, after issue of letter of award by ICAR-NIHSAD within 15 (Fifteen) days, the offer made shall be deemed to be withdrawn without any notice & earnest money forfeited.
- 7. In case of partnership firms, where no authority has been given to any partner to execute the contract/agreement concerning the business of the partnership, the tenders and all other related document must be signed by every partner of the firm. A person signing the tender form or any other documents forming part of the contract on behalf of another shall be deemed to warranty that he has authority to bind such other and if, on enquiry it appears that the persons so signing had no authority to do so, the ICAR-NIHSAD shall without prejudice to other civil and criminal remedies, cancel the contract and hold the signatory liable for all costs and damages. Each page of the tender and the schedules to the tender and annexure(s), if any, should be signed by the tenderer and should be uploaded alongwith technical bid.
- 8. Online tenders are invited under two-bids systems through e-procurement system. EMD must be deposited with Director, ICAR-NIHSAD during working hours i.e. 10:00AM to 5:00 PM on all working days (except Saturday, Sunday and Gazetted Holidays) before the last date/time for submission of bids, failing which bids will not be accepted. EMD must be in the form of Demand draft/FDR in favour of ICAR Unit, NIHSAD, Bhopal.
- 9. Tenders will be opened online by the authorized officer(s) on **17.02.2020 at 11:30 AM**. Bidders have two options to participate in tendering process at the time of opening of Bids. Bidders can come at the place of opening of bids (electronically) as done in the conventional tender process or he can visualize the process online without physically being present at ICAR-NIHSAD.
- 10. The financial bid (BOQ) will be opened for the technically qualified tenderers only. The date of opening of financial bid would be intimated to technically qualified tenderes.
- 11. Tenderer is at liberty to be present or to authorize a representative to be present at the time of opening of the tenders. The name and address of the representative who would be attending the opening of the tenders on your behalf should be indicated in your tender. Name and address of permanent representative of the tenderer, if any, may also be indicated.
- 12. An amount equivalent to 10% of the total contract value of contract is to be deposited by the selected agency/successful tenderer as Performance Security Deposit only after receiving a communication from the NIHSAD. In the event of non-deposition of the same, the earnest money will be forfeited.
- 13. No interest on security deposit and earnest money deposit shall be paid by the NIHSAD to the tenderer.
- 14. The bid validity period is 120 days from the date of opening of technical bid.
- The TDS or any other tax which is as per the rules of the Government shall be deducted at source from monthly/quarterly bill of the successful tenderer, as per rules/instructions made applicable from time to time by government.
- 16. Decision of Director, ICAR-NIHSAD shall be final for any aspect of the contract and binding no all parties. Disputes arising, if any, on the contract will be settled at his level by mutual consultation and in case of failure of settlement, dispute shall be referred to the sole arbitrator to be appointed by the Director, ICAR-NIHSAD. The decision of the sole arbitrator so appointed shall be final and binding on the parties. Arbitration proceeding shall be governed by the Arbitration & Conciliation Act, 196 as amended from time to time.

- 17. Acceptance by the Director, ICAR-NIHSAD will be communicated by fax/express letter or any other form of communication. Formal letter of acceptance and work order of the tenderer will be forwarded as soon as possible, but the earlier instructions in the fax/express letter etc. should be acted upon immediately.
- 18. The Director, ICAR-NIHSAD does not pledge itself to accept the lowest or any tenders and also reserve to itself right of accepting the tenders whole or in part keeping in view valid reasons Conditional tenders will not be accepted.
- The Director, ICAR-NIHSAD in its capacity as Principal Employer, reserves the right to modify any of the terms and conditions of the contract as mentioned in the Schedules I & II of this document, at its discretion, in the interest of the job/work.
- 20. Successful Bidder/tenderer will have to enter into a detailed contract agreement with ICAR-NIHSAD on non-judicial stamp paper of Rs. 500/- (Five Hundred Only) or appropriate value as per Rules inforce.

SCHEDULE - I

#### SCOPE OF WORK AND TENDER TERMS & CONDITIONS

#### **A** Definitions:

#### **Preventive Maintenance:**

The preventive maintenance service of the Components is as important as prompt corrective maintenance service since regular and proper preventive maintenance service ensures trouble-free performance of the Component/s. The vendor should provide at least one preventive maintenance service in one month.

#### **Corrective Maintenance:**

The corrective maintenance means identification of problem and its rectification which may include reloading of operating system, reloading/ configuring of printer, reloading/ loading of application software either developed in-house or developed by the third party, printer drivers, anti-virus softwares, smart card reader drivers etc. Although the Antivirus software will be provided by the institute

#### **Replacement of Defective Parts:**

The replacement of defective parts (electrical/ mechanical/ others) means either repair or replacement of parts at the site. If the fault is of serious nature and requires shifting of the Component/s or any part thereof the vendor should provide similar components part/s for uninterrupted continuation of work till the re-installation of the Component/s or part/s which were shifted for repair/ replacement. The defective part should be replaced/ repaired without any cost to the ICAR-NIHSAD.

#### **Shifting of Components:**

The shifting of Components means moving the Components from one place to the other place for carrying out the repair work.

#### **Working Day and Hours:**

ICAR-NIHSAD working hours is 10:00 hrs to 17:00 hrs on weekdays i.e. Monday to Saturday with Second Saturday as holiday. However, there may be cases where vendor's representative have to attend the fault before/ after the office hour and on holidays too and the vendor should not charge any extra-cost for such operation and maintenance work.

#### B Items/Services under the scope of work

- i. Desktop, printer, UPS & other accessories like mouse, key boards, web camera etc. Following number of items available in ICAR-NISHAD will be covered under AMC such as Desktops-81, Printers/scanners-32, UPS-51, IBM Server-1, Gigabytes Switches-09 (24 port-3, 16 port-03, 08 Port-01, 5 port-02) 10/100 switches (8 port-02 Nos), Access Points-06, Wifi adaptors-05, Lan Extender-01 pair, TP link Sender/receiver- 02 pairs, Wireless network dongle-04, D link Router-01 and STP and UTP Cable with IOB to entire network (List of items are enclosed as Annexure-III)
- ii. Network Management Services.
  - ICAR-NIHSAD is having 100 Mbps bandwidth NKN network connection under the maintenance of RailTel.
- iii. Virus Management Services (Desktops of ICAR-NIHSAD are installed with quick heal antivirus software).
- iv. OS Administration and Network Security and LAN server administration.
- v. Backup & Recovery Management Services.
- vi. Application Management Services.
- vii. Day-to-day operation, break down and preventive maintenance.

#### C Visiting Hours:

The firm should ensure the presence of their engineers/technicians in all working day of the institute from 11.00 AM to 1.00 PM for carrying out AMC irrespective of any call or notification from the Institute. In addition, the Institute shall notify the vendor of any errors and

malfunctions, which occur when the computer system is being used by the Institute. All complaints will be registered by the I/c Computers or any authorised person. The contractor should attend the complaint on the same day or next day morning (If complaint booked in after noon). During the period of fault rectification, a suitable & justified alternate arrangement should be provided. Complaints regarding server and LAN including hardware and software should be attended on the same day on priority.

#### D Routine/Daily Maintenance Work to be carried out at the site:

- i. The AMC will cover maintenance, repair, replacement and service for the hardware and software of Personal Computers, Laptops, Printers, Peripherals, UPSand Networking including UTP cable wires. (Detailed list of computers, printers and other peripherals is enclosed as Annexure-II).
- ii. A record of complaints shall be maintained by the firm which shall contain date and time of reporting the problem, date and time of clearing the problem and actual problem attended. This report shall be enclosed along with the quarterly bills for payment. Complaint book at the site should have the contact Number, Telephone & FAX numbers of the firm and the attending staff.
- iii. The agency should ensure the proper functioning of network system and in case of any failure, they should rectify without any delay. In case of NKN related issue, they should contact RailTel/NKN officials for complaint registration and follow-up till the issue get rectified.
- iv. The staff should be able to attend all the faults and carryout repair & maintenance of the computer and peripherals.
- v. The agency shall provide operational Support for applications running and added from time to time even if they are under warranty or guarantee. It is the responsibility of agency to contact costumer care or supplying firm to facilitate warranty or guarantee claim of the computers and accessories which are added newly during the contract period.
- vi. In case of computers, the AMC includes the Hard Disk, DVD writer, Floppy Drive, CD-Rom Drive, Power Supply, UPS Controllers Cards, Display Cards, Monitor, Processor and ICs. In case of Printers/Scanners all the parts along with data cable, printer head, etc. should be supplied by the firm.
- vii. Network management services should be inclusive of maintenance and replacement of RJ45 connectors, switches, network cables or any other accessories related to LAN/WAN.
- viii. The agency shall not replace any parts without the consent of The Director / I/C Computer cell, NIHSAD. In case part is supplied by NIHSAD, the Parts removed/replaced shall be the property of the NIHSAD, although in case of replacement the old damaged parts may be kept by the vender with the consent of the Institute.
- ix. The software maintenance includes system recovery, loading/reformatting of software/discs with software like window 10, window 7, windows 2000, windows 2003, windows XP, MS office, Internet Explorer, Netscape, Outlook Express, Anti-virus software, Data retrieval and installation/removal of any other software developed/purchased by NIHSAD from time to time etc. It also includes removal of virus and re-installation of software, if corrupted. Also should provide Support in troubleshooting of commercial software packages.
- x. Any part/item required to be replaced should be of same or superior make and model.

#### E. Preventative Maintenance:

The vendor shall ensure that all the hardware covered under this contract are attended for preventative maintenance and are cleaned during preventive maintenance. The vendor shall follow a **strict preventive maintenance schedule, which must be carried out once in a month,** for each machine. The vendor must ensure that he maintains a datasheet for each machine available, which will contain the configuration of each machine and dates of preventive breakdown maintenance carried out by the contractor. On no account, equipment or its accessories shall be allowed to be taken out of its normal installed location for preventive maintenance.

Preventive maintenance shall constitute the following:

i. Physical inspection & cleaning up of all the hardware covered under this contract with a **blower/cleaner as per requirement** and wiping the surface of the systems with a good quality cleaning liquid, cloth and brush etc.

- ii. Checking & testing of UPS batteries and submit the status of batteries. Although the batteries of UPS will be provide by the NIHSAD for the replacement.
- iii. Checking up of printers for paper dust and smooth operation & cleaning of printer head.
- iv. Informing concerned user in case of any impending crash of hard disk so that remedial action for taking data backup could be initiated.
- v. Checking of virus & removal of virus if any.
- vi Removal of temporary files in each desktop computers for smooth running of the system.
- F Downtime calculation

**Downtime:** Downtime is defined as the time during which the systems and/or services running on it are not available or are deemed to be not available to the users in part or full due to any non – functioning, repairs / problems etc. The penalty for downtime will be counted from the time problem is reported to the bidder, electronically or telephonically or by such other means till problem is solved / rectified to the satisfaction of user. Penalty shall be applicable once the admissible down time is crossed. The admissible down time is computed as per the following rules:

Maximum Admissible Downtime: Clients and Peripherals – Maximum 20 office hours calculated over a period of Three months per machine/system for all machines except server & Network.

#### Note:-

1. Maximum downtime in a day will be equal to run time even if machine (for all machines PC, LT, Printer, Scanner etc.) is down for 24 hours i.e. if Desktop is down from 9 am to 9 am (next day) the total down time will be 7 hrs. (10AM to 5PM) and not 24 hrs.

For Server & Network: -

If connectivity is available but Server or Network does not work.

Down time Calculation: -

i) For individual m/c it will be counted with the m/c down time (as per above rule).

OR

- ii) In case of total failure maximum allowable time will be 72 hrs in 3 months & counted as per the real clock time (not as per office time).
- 2. In case of intermittent failures and repetitive problem due to improper diagnosis or repairs, then it will be treated as continuously down from the time of first fault reporting
- 3. Deemed down: A system although up but is not able to deliver services because of non-availability of connected system. For example, if switch is down, all PCs connected to it will also be deemed as down. If server is down, all PCs connected to it will also be deemed as down
- 4. Few Example of down calculations:
  - When server is down server and all hardware connected to sever directly or indirectly will be deemed as down.
  - When Hub/Switch is down Hub/Switch and all other related items connected to Hub/ Switch.
  - Only PC is down PC, Only Printer is down printer.
  - Router and Modem Entire office h/w are down.

#### **G.** Other Terms and Conditions

The contract is subject to the condition that the tenderer will comply with all the laws and acts of

- Central Govt., State Govt. relating to this contract made applicable from time to time.
- Standards of Performance: The bidder shall perform the service and carry out its obligation under the contract with due diligence, efficiency and economy, in accordance with generally accepted technique and practices used in the industry and with professional engineering and consulting standards recognized by international professional bodies and shall observe sound management engineering practices. It shall employ technical and engineering practices. It shall employ appropriate advance technology and safe and effective equipment, machinery material and methods. The bidder shall always act, in respect of any matter relating to this contract, as faithful advisors to the NIHSAD and shall at all times, support and safeguard the NIHSAD legitimate interests in any dealings with Third Parties.
- The Contractor shall maintain adequate spare machines and other spares at site to facilitate any temporary replacement.
- 4 In case of any piracy problems the agency will be solely responsible for the same.
- Some of the machines, LAN/WAN are installed in the Bio-containment area. For attending the same, bio safety rules/ regulations of this Institute to be followed strictly. Any violation will result in termination of the contract.
- The Agency shall further be bound by and carry out the direction/Instructions given to them by the COMPUTER INCHARGE, NIHSAD or the officers designated by him/her in this respect, from time to time. All the material/parts, will be replaced/used will require the prior consent of the Computer I/C regarding quality etc.
- Confidentiality of Information: The agency and its staff shall maintain strict confidentiality of information. No part of information can be disclosed to any party in any form during the contract period or thereafter. The incidental disclosure of information to agency and its staff is just for carrying out the job assigned and no more. Any violation or attempt of Violation may lead to legal action under appropriate law.
- The staff so provided by the agency under this contract will not be the employee of the NIHSAD and there will be no employer-employee relationship between the NIHSAD and the person so engaged by the contractor in the aforesaid services.
- 9 The contractor will discharge all his legal obligations in respect of the workers/supervisors to be employed/deployed by him for the execution of the work in respect of their wages and service conditions and shall also comply with all the rules and regulations and provisions of law in force that may be applicable to them from time to time.
- The contractor shall indemnify and keep indemnified the NIHSAD from any claims, loss or damages that may be caused to it on account of any failure to comply with the obligations under various laws. In case of any dispute, the decision of Director, NIHSAD shall be final and binding on the contractor.
- To have proper coordination in working, the Contractor/Service provider Agency authorities would visit the working areas frequently and contact the concerned In-charge officers/administration for any clarification if required.
- Any change in service provider or contractual worker should be done in consultation with NIHSAD authority. Abrupt and unjustified changes will not be accepted.
- The agency shall be responsible for good conduct and behavior of its engaged man power. If the service of the engaged manpower is found not up to the mark, he/she should be replaced within 24 hours from the receipt of letter from the concerned department.
- The vendor will not subcontract or permit anyone other than their company personnel to perform any of the work, services or other performance required of the vendor under the AMC / Service Contract without the prior written consent of the NIHSAD.
- The agency shall ensure that the Telephones, Computers, Internet Connection, Electricity will not be misused. If it is found misused, the heavy penalty will be put on the agency. Similarly recovered data should not be shared with anybody.
- Returning of the equipment after completion of the contract period: The Bidder shall handover (return) all the equipment back to the Department after the contract period in good and working condition.

- Review: Both NIHSAD and agency shall conduct periodical reviews from time to time by examining the automated reports generated by bidder such as downtime reports, uptime reports, logbooks etc.
- The payment will be made on a quarterly basis at the end of the each quarter and subject to submission of satisfactory service report from the users departments and item wise preventive maintenance and cleaning reports. Payment will be made through core (NEFT) Banking for which the proof regarding account No. with SBI is provided along with Tender form. Payment of last quarter will be made only after the vendor fulfills all the contractual obligations i.e. replacement / repair of Component /s and its part /s maintained under AMC like. However, the sequence of payment would be as given below:-
- Upon verification of records as mentioned above and the attendance of contractual persons, the administration would release the payment via BANK TRANSFER in the account of contractor.
- Income Tax (TDS) will be deducted from the payments due for the work done as per rule.
- The Institute will not be responsible either to the Contractor or to its workers deployed at this Institute for any medical assistance/injuries/death or any kind of loss occurred to contractual labours.
- In case of any damage to the NIHSAD property by the teams engaged, the same will be recovered from the agency.
- The Director, NIHSAD reserves the right to reject any or all tenders/quotations in whole or in part without assigning any reason thereof. The decision of Director, NIHSAD shall be final and binding on the Contractor/Agency in respect of clause covered under the contract
