INSTRUCTIONS FOR BIDDER

- 1. The tender form/bidder documents may be downloaded from the website: <u>https://eprocure.gov.in</u>. Online submission of Bids through Central Public Procurement Portal (<u>https://eprocure.gov.in</u>) is mandatory. Manual/Offline bids shall not be accepted under any circumstances.
- 2. Tenderers/bidders are requested to visit the website <u>https://eprocure.gov.in</u> regularly. Any changes/modifications in tender enquiry will be intimated by corrigendum through this website only.
- 3. In case, any holiday is declared by the Government on the day of opening, the tenders will be opened on the next working day at the same time. The Director, ICAR-NIHSAD reserves the right to accept or reject any or all the tenders.
- 4. The interested Firms are required to deposit (in original) the Earnest Money Deposit (EMD) of the amount mentioned against item in the form of Account Payee Demand Draft/FDR from any of the Commercial Banks in favour of <u>ICAR Unit, NIHSAD, Bhopal</u> payable at Bhopal may be addressed to Director, ICAR-NIHSAD, Bhopal 462022. The EMD can also be deposited online in an acceptable form on or before bid opening date and time as mentioned in the Critical Date Sheet. In case of depositing the EMD through online mode, proof of EMD (UTR No or any other) must be submitted alongwith tender. No quotation shall be considered without the earnest money deposit. The earnest money will be refunded only after the finalization of the procurement and no interest will be paid on earnest money.
- 5. - 1. The tenderer shall quote rates, which will include the delivery & other incidental charges. Taxes etc. should be indicated separately.
- 2. The rates should be quoted as per the BOQ uploaded on the CPP Portal (reference may be obtained from Annexure III). Taxes, if any, should be indicated separately. It must be noted that the contract shall be awarded to the firm which fulfills all the required terms and conditions and remains L-1 for any particular items.
- 3. The firm must also possess valid PAN No., GST No. registration number and a copy of the same must also be enclosed with the tender documents.
- 4. The -80°C Deep Freezer quoted should be of latest technology. The spare parts of the -80°C Deep Freezer quoted should be available for next 10 years.
- 5. Modification in the tender documents after the closing date is not permissible.
- 6. The successful firm shall have to supply the -80°C Deep Freezer within 30 days from the date of confirmed supply order and if the materials are not supplied in time then EMD shall be forfeited. The rates quoted shall be valid for One Hundred & Eighty days (180) from the date of opening of tender.

- 8. The Director, ICAR-NIHSAD shall have the right to reject all or any of the offers, accept more than one offer, and assign part of the job.

<u>Specification for -80°C Deep Freezer – 1 No.</u>

1.	Capacity: Upright Vertical -80°C deep freezer with 480 litres or above capacity with atleast three adjustable compartments of stainless steel shelves.
2.	Interior: 304L grade SS; Exterior: powder coated finish on heavy duty steel gauge.
3.	Compressors: It should have two fully functional compressors (operational at 190-270V, 50 Hz) with 10 year warranty. In case of failure of one compressor; the other compressor should continue to the cooling function.
4.	Insulation: Ultra-thin vacuum insulation nanogel panel with 5 year warranty.
5.	Refrigerant: CFC-FREE, HCFC-FREE non-inflammable or eco-friendly natural hydrocarbon refrigerants, Refrigeration system: hermetically sealed cascade refrigeration system.
6.	Should have provision for CO ₂ / LN2 backup systems.
7.	Should have microprocessor based programmable control panel with LED/LCD digital display.
8.	Cool down time should be \leq 4.5 hr.
9.	Should have battery back-up and; audible and visual alarms for temperature, power failure, system failure, battery low etc.
10.	The power consumption should be $\leq 12.5 \ (\pm 0.15) \ \text{KW/day}$. Noise output should be $\leq 56 \ \text{dB}$.
