Scope of Work for Transportation of Furnace Oil

Other Terms & Conditions:

- 1) The bidder shall have specific tanker for Furnace oil transportation as per the standard specifications.
- 2) The rates quoted shall be applicable for two years and may be extended further on mutual consent. Hence the firm may submit their offer accordingly.
- 3) Transporter will arrange the tanker for transportation of furnace oil within 48 hours after receiving of the indent.
- 4) Furnace oil should reach NIHSAD Bhopal within 24 hours after filling at the depot.
- 5) Transportation charges will be paid after the receipt of the furnace oil in good condition by NIHSAD Bhopal. In case of any short supply of Furnace oil by transporter, the amount will be recovered/deducted on actual basis from billing amount of transportation charges.
- 6) Transporter will be solely responsible for supplying the required quantity of Furnace oil in good condition at the destination and NIHSAD shall not be responsible for any mishap occurring during transportation.
- 7) Transporter will be responsible for complete documentation works related to RTO whereas NIHSAD will only arrange the insurance of Furnace oil to be transported as per the requirement.
- 8) The Calibration of furnace oil tanker from the supplier of Furnace oil shall be done by the transporter at his own cost on yearly basis & calibration report shall be submitted to purchaser (NIHSAD).
- 9) The tanker must be weighed before and after filling the Furnace oil through local authorized weighing vendor on his own cost and shall submit the weighing receipts on delivery of the Furnace oil at NIHSAD.
- 10) The contract can be terminated with two months prior notice to the firm from NIHSAD side.
