#### 1) Area of Electrical Sub-Station: -

Sr. No.	Dimension	Specification
1.	Length of Sub-Station	31 meter
2.	Width of Sub-Station	27 meter
3.	Depth for laying stone aggregate	0.1 meter

- 2) Quantity of stone aggregate required for leveling = **3000 cubic feet (85 cubic meter)**
- 3) Size of Stone aggregate = **40 mm**
- 4) Levelling of Sub-Station Yard Surface area (specified above) with Stone Aggregates as per requirement
